The undersigned counsel hereby certifies that he is unaware of any unresolved formal or informal objections or responses to the First Interim Fee Application of Sitrick And Company ("Sitrick") for Compensation for Services Rendered and Reimbursement of Expenses as Corporate Communications Professionals Retained by the Debtors for the Period From June 10, 2013 through August 31, 2013 [Docket No. 982] (the "Application"), filed by counsel for Sitrick on October 28, 2013 in the above-captioned case of the debtor and debtor-in-possession (the "Debtor"). The undersigned counsel further certifies that he has reviewed the Court's docket and no objection to the Application appears thereon.

Pursuant to the Order Pursuant to Bankruptcy Code Sections 105(a) and 331 Establishing Interim Compensation Procedures [Docket No. 330] (the "Interim Compensation Order"), the

notice of the Application set a deadline of November 7, 2013 at 4:00 p.m. (Eastern) (the "Objection Deadline") for receipt of objections to the Application, and no extension of the Objection Deadline was granted. A hearing was originally set for November 14, 2013 at 10:00 a.m. (Eastern).

Accordingly, pursuant to the Interim Order, Sitrick requests that the Court approves and authorizes the Debtor to pay (or authorize Sitrick to deduct from its retainer): (a) 100% of the fees requested in the Application as interim compensation for professional services rendered as corporate communications and public relations consultants to the Debtor for the period from June 10, 2013 through August 31, 2013 in the sum of \$178,074.75; and (b) 100% of the actual and necessary expenses requested in the Application in the sum of \$33,566.64.
