**ADDENDUM TO THE DECLARATION OF MICHAEL HENKIN IN OPPOSITION TO
THE DEBTOR’S MOTION FOR ENTRY OF AN ORDER AUTHORIZING THE
DEBTOR TO AMEND THE DIP FACILITIES**

The Official Committee of Unsecured Creditors (the “Committee”) of Exide Technologies (the “Debtor” or “Exide”), the above-captioned Debtor² and Debtor-in-Possession, by and through its counsel, submits this addendum to the *Declaration of Michel Henkin in Opposition to the Debtor’s Motion for Entry of an Order Authorizing the Debtor to Amend the DIP Facilities and the Final DIP Order* (the “Henkin Declaration”) which is being filed contemporaneously.

In order to address certain confidentially concerns expressed by the Debtor, the Committee and other parties-in-interest, the Henkin Declaration refers to certain alternative debtor-in-possession lenders as “Party 1”, “Party 2”, “Party 3”, “Party 4” and “Party 5,” and does not disclose the identity of these potential lenders.

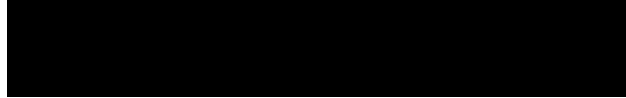
