thereon and good and sufficient cause appearing therefor; it is hereby

Unless otherwise defined herein, capitalized terms used herein shall have the meanings ascribed to them in the Objection.

ORDERED, ADJUDGED, AND DECREED that:

- 1. The relief requested in the Objection is GRANTED, as set forth herein.
- 2. The hearing with respect to proofs of claim numbers 1656 and 1052 (collectively, the "Adjourned Claims") is hereby adjourned, subject to the Reorganized Debtor's right to notice the Adjourned Claims for a future hearing.
- 3. The No Liability Employee or Retiree Claims listed on Exhibit A are hereby disallowed and expunged in their entirety as set forth in Exhibit A.
- 4. The Reorganized Debtor's objection to each Claim addressed in the Objection constitutes a separate contested matter as contemplated by Bankruptcy Rule 9014. This Order shall be deemed a separate Order with respect to each claim. Any stay of this Order pending appeal by any of the Claimants subject to this Order shall only apply to the contested matter which involves such Claimant and shall not act to stay the applicability and/or finality of this Order with respect to the other contested matters covered hereby.
- 5. The Reorganized Debtor shall retain and shall have the right to object in the future to any of the proofs of claim listed on Exhibit A hereto on any additional grounds, and to seek to amend, modify, and/or supplement this Order as may be necessary. In addition, the Reorganized Debtor's rights are reserved to file future objections to Claims asserted in proofs of claim that have been or may subsequently be filed in the Chapter 11 Case, or Claims that may be listed on the Schedules, on the grounds set forth herein or any other appropriate grounds that bankruptcy and non-bankruptcy law permits.
- 6. Nothing contained herein shall constitute, nor shall it be deemed to constitute, the allowance of any Claim asserted against the Debtor or the Reorganized Debtor, including, but not limited to the Disputed Claims or the Adjourned Claims.

- 7. This Court shall retain jurisdiction over the Debtor, the Reorganized Debtor, and the Claimants whose Disputed or Adjourned Claims are subject to the Objection with respect to any matters related to or arising from the Objection or the implementation of this Order.
- 8. The Reorganized Debtor is authorized and empowered, to execute and deliver such documents, and to take and perform all actions necessary to implement and effectuate the relief granted in this Order.
- 9. The Reorganized Debtor's Claims and Noticing Agent, Garden City Group, LLC, is hereby directed to serve this Order, including any relevant exhibits, and to take and perform all actions necessary to implement and effectuate the relief granted in this Order.
