PLEASE TAKE FURTHER NOTICE that the objection or response (the "Objection") deadline to the Motions have been extended for the Reorganized Debtor in the above-captioned case until **September 11, 2017 at 4:00 p.m. (Eastern Time)** (the "Objection Deadline"). The Objection, if one, must be filed with the Court and served upon the undersigned counsel for the GUC Trust so as to be received by the Objection Deadline.

PLEASE TAKE FURTHER NOTICE that the hearing on the Motions will be held before the Honorable Kevin J. Carey, United States Bankruptcy Judge, at the United States Bankruptcy Court located at 824 North Market Street, 5th Floor, Courtroom #5, Wilmington, Delaware 19801.
