PLEASE TAKE NOTICE that on July 31, 2015, Exide Technologies, the reorganized debtor in the above-captioned bankruptcy case (the "Reorganized Debtor"), filed the *Reorganized Debtor's (Substantive) Twenty-First Omnibus Objection Pursuant to Bankruptcy Code Section 502(b), Bankruptcy Rule 3007, and Local Rule 3007-1 to Certain (A) Misclassified Claims, (B) Reduce and Allow Claims, (C) Previously Discharged Claims, and (D) No Liability Claims* [Docket No. 4435] (the "Twenty-First Omnibus Claims Objection"),² with the United States Bankruptcy Court for the District of Delaware, 824 Market Street, 3rd Floor, Wilmington,

Delaware 19801 (the "Bankruptcy Court"). A copy of the Twenty-First Omnibus Objection was previously served upon you.

PLEASE TAKE FURTHER NOTICE that on September 15, 2015, the Bankruptcy Court entered the *Order Sustaining Reorganized Debtor's (Substantive) Twenty-First Omnibus Objection Pursuant to Bankruptcy Code Section 502(b), Bankruptcy Rule 3007, and Local Rule 3007-1 to Certain (A) Misclassified Claims, (B) Reduce and Allow Claims, (C) Previously Discharged Claims, and (D) No Liability Claims* [Docket No. 4481] (the "Order"). Counsel agreed to adjourn the hearing on the Twenty-First Omnibus Objection, *inter alia*, with respect to claim no. 321 filed by Electric Conversions subject to the right to re-list this claim for hearing.

PLEASE TAKE FURTHER NOTICE that a hearing to consider the relief sought in the Twenty-First Omnibus Objection with respect to the Electric Conversions claim will be held on **September 18, 2018 at 2:30 p.m. prevailing Eastern Time** before the Honorable Kevin J. Carey, United States Bankruptcy Judge, at the United States Bankruptcy Court for the District of Delaware, 824 Market Street, 5th Floor, Courtroom No. 5, Wilmington, Delaware 19801.
