**NOTICE OF WITHDRAWAL OF THE DEBTOR’S (SUBSTANTIVE)
TWENTY-SECOND OMNIBUS CLAIMS OBJECTION PURSUANT
TO BANKRUPTCY CODE SECTION 502(b), BANKRUPTCY RULE 3007,
AND LOCAL RULE 3007-1 AS IT RELATES TO PROOF OF CLAIM
NOS. 2206 AND 2207 FILED BY BOBBY BOYD AND ALBERT ATKINS**

PLEASE TAKE NOTICE that on July 31, 2015, Exide Technologies, the reorganized debtor in the above-captioned bankruptcy case (the “Reorganized Debtor”), filed the *Reorganized Debtor’s (Substantive) Twenty-Second Omnibus Objection Pursuant To Bankruptcy Code Section 502(b), Bankruptcy Rule 3007, And Local Rule 3007-1 To Certain (A) Misclassified Claims; (B) Reduce and Allow Claims, (C) No Liability Claims, (D) Insufficient Documentation Claims, and (E) Substantive Duplicate Claims* [Docket No. 4436] (the “Twenty-Second Omnibus Claims Objection”).

PLEASE TAKE FURTHER NOTICE that pursuant to the Twenty Second Omnibus Claims Objection, the Reorganized Debtor objected, *inter alia*, to: (i) Proof of Claim No. 2206 (the “Boyd Claim”) filed by Bobby Boyd listed on Exhibit C – “No Liability Claims” and Exhibit D – “Insufficient Supporting Documentation Claims” to the Twenty-Second Omnibus Claims Objection and (ii) Proof of Claim No. 2207 (the “Atkins Claim”) filed by Albert Atkins listed on Exhibit C – “No Liability Claims” and Exhibit D – “Insufficient Supporting Documentation Claims.”

PLEASE TAKE FURTHER NOTICE that, pursuant to the terms of the parties' respective settlements, the Reorganized Debtor, hereby withdraws its objections to the Boyd Claim and the Atkins Claim contained in the Twenty-Second Omnibus Claims Objection.
